EXECUTIVE DIRECTOR REPORT

Dear PACS Community:

Pennyrile Allied Community Services (PACS) is a private, nonprofit organization that uses a broad range of public and private resources to provide low-to moderate income individuals and families the opportunity to improve the quality of life for themselves, their family and their communities. PACS oversees a wide range of programs and services to help improve lives as we strive to meet our mission of, "Empowering low-income individuals to become self-reliant through community service, assistance, education, and partnerships "

Sixty years ago, in 1964, President Johnson signed the Civil Rights Act and the Economic Opportunity Act. These proved to be essential pieces of the War on Poverty and civil rights legislation were quick to follow and became intertwined from the federal level down to the grassroots level. On July 1, 1966, The Pennyrile CAA provided services to 3 counties. (Christian, Todd and Trigg). Also, in 1966 the Hopkins-Muhlenberg CAA was created to serve 2 counties. (Hopkins, Muhlenberg). Fifty years ago on July 1, 1974, these 2 community action agencies merged to create PACS which now services 9 counties in west Kentucky as our primary serve area.



Much has happened in the last 50-60 years. As you can see from the chart below, the challenges for everyone in meeting their needs continued to increase and has put even more headwinds for those who are low to moderate income individuals and families. Compounding this is the increased number of single-family households which creates even more difficulties in meeting the needs of our communities.

The Title III program is contracted through the Pennyrile Area Development District with funding from the Older American's Act. All services are at no charge to individuals 60 years and older. Donations are encouraged and these donations are budgeted back into the county where the donation was received. Donations are particularly important as they are used to expand services in that county.

Home Care is state funded through the Department of Aging and Independent Living and the Pennyrile Area Development District. This program provides in-home services to seniors who have functional impairments that may prevent them from completing the activities or instrumental activities of daily living. Home Care clients must be assessed by a case manager to be declared eligible for this program. There is no charge for these programs, but donations are encouraged to help expand services.



Community Services Block Grant (CSBG)

Pennyrile Allied Community Services, Inc. (PACS) administers the Community Services Block Grant Programs (CSBG) through a contract with the Cabinet for Health and Family Services, Department for Community Based Services. CSBG is designed to address the needs of the low-income residents and to assist them with working towards becoming self-reliant.

The Community Service Coordinators housed in each of the nine counties provide emergency assistance through CSBG funding. PACS Coordinators also provide case management to individuals and referrals to community partners to assist clients with employment, financial management, education concerns, cooking/shopping on a budget and maintaining a home. The focus of CSBG is to provide services as part of case management, which in turn leads to self-reliance.

Through CSBC, various non-federal funding, case management, home visits, telephone calls, referrals and community involvement PACS Community Services has assisted over 1,000 households with over \$227,000 in one of the following areas of need: Employment, Education, Housing, Income and Asset Building, Health and Civic Engagement.

Low-Income Home Energy Assistance Program (LIHEAP)

The Low-Income Home Energy Assistance Program (LIHEAP) helps keep families safe and healthy through initiatives that assist families with energy costs. Over 12,800 households in the Pennyrile area received \$2,682,174 in home energy assistance benefits.

- LIHEAP Summer Subsidy component operated from July 25, 2023 to September 22, 2023 with 3,086 Households receiving \$595,486 in energy assistance benefits.
- LIHEAP Fall Subsidy component operated from October 16, 2023 to December 20, 2023 with 3,331 Households receiving \$454,973 in energy assistance benefits.
- LIHEAP Winter Crisis component started January 9, 2024 and ended March 31, 2024 with 3,747 households receiving \$1,240,142 in energy assistance benefits.
- LIHEAP Spring Subsidy component started on April 16, 2024 and ended on May 31, 2024 with 2.637 households receiving \$391.571.

Low-Income Home Water Assistance Program (LIHWAP)

The Low-Income Home Water Assistance Program (LIHWAP) assisted families with water and wastewater cost. 904 households in the Pennyrile area received \$87,250 in water and wastewater assistance benefits.

FAMILY FIRST PRESERVATION PROGRAMS

These in home services are designed to prevent the removal of children from their families. FFP serves all 17 counties in Western KY. Services are provided through a variety of evidence-based practices and include but not limited to parenting skills, assisting with the reunification of families, advocacy, and community resources.

Community Collaboration for Children

CCC provides preventative services and does not need a referral source. This program is open to all families without DCBS involvement.

Motivational Interviewing

MI is a method of counseling used to promote behavior change by encouraging clients to consider their personal goals and what they are doing to work towards these goals.

*Length of Time: 3 hours per week for 13 weeks *Maximum Caseload: 6 *Age 0-18

Family Functional Therapy

FFT is a short-term prevention program for at risk youth with behavioral or emotional problems. It focuses on developing a positive relationship between family members.

*Length of Time: 1.5 hours per week for 12-15 weeks *Maximum Caseload: 6 *Age 11-18

Homebuilders

Provides intensive in-home counseling and support services for families who have children at imminent risk of removal or reunification.

*Length of Time: 10 hours per week for 4 weeks *Maximum Caseload: 2 *Age 0-18

Trauma-Focused Cognitive Behavioral Therapy

TTF-CBT is an evidence-based intervention for children and adults who have symptoms associated with trauma exposure.

*Length of Time: 1-1.5 hours per week for 8-25 weeks *Maximum Caseload: 6 *Age 5-17

Parent-Child Interaction Therapy

PCIT is an evidence-based intervention in which parents are coached by a trained therapist in behavior management and relationship skills.

*Length of Time: 1 hours per week for 12-20 weeks *Maximum Caseload: 6 *Aae 2-7

RETIRED AND SENIOR VOLUNTEER PROGRAM (RSVP)

The Retired and Senior Volunteer Program (RSVP) recruits and places volunteers that are fifty-five years of age and older in public agencies, secular or faith-based private/public non-profit organizations, or proprietary heath care organizations. RSVP offers flexibility and choice as it matches the personal interest and

skills of older Americans with the community needs throughout Caldwell, Christian, Hopkins, Lyon, Muhlenberg, Todd, and Trigg Counties.

RSVP is federally funded by AmeriCorps Seniors and matched with local money from Fiscal Courts in Christian County, Hopkins County, Muhlenberg County, Trigg County, United Way of the Pennyrile, and Fundraising.

RSVP's fiscal program year runs April through March. RSVP had a total of 346 volunteers who donated 73,635 service hours at 59 stations doing 83 different jobs throughout our seven counties. The Independent Sector estimated the value of a volunteer's time in Kentucky at \$28.53 per hour. Multiplying that number by the number of hours served was a savings of over \$2,100,806.55 to the non-profit, government agencies, and proprietary health care organizations helped by RSVP Volunteers for 2023-2024.

Tax Counseling for the Elderly (TCE)



The mission of the TCE preparation program is to assist elderly and low-income taxpayers in satisfying their tax responsibilities by providing free tax return preparation. To establish the greatest

degree of public trust the IRS- certified volunteers are required to maintain the highest standards of ethical conduct and provide quality service. PACS along with the RSVP program facilitates to ensure TCE operates efficiently each tax season. PACS had 21 TCE Volunteers that dedicated an amazing 4,316 service hours completing 3,120 Federal and State tax returns with over \$1.5 million in Federal dollars refunded to 1,507 elderly taxpayers. This tax season we were able to structure two temporary sites in Caldwell and Livingston.

PACS serves Christian, Caldwell, Crittenden, Hopkins, Livingston, Lyon, Muhlenberg, Todd, & Trigg counties in the Pennyrile area. We at PACS Transportation are proud to be providing the residents of the Pennyrile Area with a service to meet their transit needs.

With the grand funds received in FY24, we purchased five new minivans this year, and we also have six transits and one city bus on order. With the KPTA Bid 11 being open, we are hoping to purchase more transits and more city buses.

We are still working towards building a new transportation building in Hopkinsville to replace the old transportation annex building. It seems to be getting closer to reality as we are currently waiting for bidding to start the new construction. Future plans on that building include a maintenance facility to be able to do maintenance on our own vehicles making it more cost efficient and better maintained vehicles. In FY21 PACS was awarded 5311 CARES Capital for 1.5 million to renovate the Transportation building on 1200 S. Clay St. We have also been granted \$500,000 additional funds through the 5339b grant to help cover the increasing costs that have risen over the past few years due to the pandemic.

We continue to operate City Transit Systems-PACS bus routes for the city of Hopkinsville (3routes). They provide different routes to different areas of these counties to assist with transit needs and give people the independence to go when they want without having to rely on someone else to take them. Ridership is slowly getting back to normal.

WEATHERIZATION

The scope of the Weatherization program continues to be one of assisting in the achievement of a more helpful dwelling environment and maximum energy conservation for low-income clients.

The priority measure PACS performs on a house or mobile home is checking the energy systems of the dwelling. This includes furnaces, space heaters, fireplaces, water heater jackets, duct wraps and duct repairs if needed, flue repairs, safety materials and safety repairs. A National Energy Audit is performed on each house and a Manufactured Energy Audit is performed on each mobile home PACS selves. These audits show the areas the Weatherization program should address while performing Weatherization Services.

As the second priority, the major infiltration work is completed. This includes repairing and/ or replacing missing doors, panels, panes; missing windows and/or window-panes; repairs to supply and return ducts; and major envelope holes. The general heat waste priority is then repaired, blocking is installed, attic bypasses are addressed and sealed, roof repair, which is very limited by regulations, is completed. If necessary, the walls of the dwelling are then repaired and insulated. Floors are repaired, ground cover is installed underneath the structure, pipe wrap, and insulation is completed. With LIHEAP funds combined with DOE, the Weatherization program has completed 1 home, 1 deferral and 6 are currently in progress.

ATMOS (C.A.R.E.S.)

The Demand Side Management (DSM) partnership program with Atmos Gas Company is intended to provide current low-income Atmos Gas residential consumers assistance and advice concerning energy efficient improvements specific to their homes.

The program is offered at no cost to the participant. This program acts as a "piggy-back" program in conjunction with PACS Weatherization program to ensure the most energy saving measures are completed to conserve the greatest amount of energy. Caldwell, Christian, Crittenden, Hopkins,

Livingston, Lyon, Muhlenberg, Todd, and Trigg counties are served by CARES.


The goal of this program is to reduce the energy usage of Atmos Gas residential customers.

For one to receive the CARES benefits, one must be eligible for PACS Weatherization program.

The program guidelines are based on the 200% OMB Poverty Guideline. These guidelines are based on the number of people in a household and allowable yearly income.


